Represents shares of the Issuer's Class A Common Stock purchased for the Reporting Person's account under the Issuer's Employee Stock Purchase Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. (1) On October 4, 2010, the Reporting Person received a grant of performance shares which vested or expired on October 1, 2013. On October 1, 2013, 11,531 shares vested and are reported herein as acquired non-derivatives securities. The remaining 2,306 shares granted October 4, 2010 have expired.
