("Limited") and various private investment accounts (the "Accounts") held in the aggregate 5,633,300 shares of common stock, par value \$0.001 per share (the "Shares"), of Seattle Genetics, Inc. Jonathan Gallen possesses sole power to vote and direct the disposition of 4,500,000 Shares held by Ahab, International, Queequeg and Limited.
