**NOTES TO THE UNAUDITED CONDENSED FINANCIAL STATEMENTS**

**NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accompanying financial statements have been prepared by the Company in accordance with Article 8 of U.S. Securities and Exchange Commission Regulation S-X. In the opinion of management, all adjustments (which include only normal recurring adjustments) necessary to present fairly the financial position, results of operations and cash flows at June 30, 2013 and 2012 and for the periods then ended have been made. Certain information and footnote disclosures normally included in financial statements prepared in accordance with U.S. generally accepted accounting principles have been condensed or omitted. Management suggests these condensed financial statements be read in conjunction with the December 31, 2012 audited financial statements and notes thereto included in the Company's Form 10-K. The results of operations for the periods ended June 30, 2013 and 2012 are not necessarily indicative of the operating results for the full year.

**Reclassification** Certain amounts in prior-period financial statements have been reclassified for comparative purposes to conform to presentation in the current-period financial statements.

**NOTE 2 GOING CONCERN**

The Company's financial statements have been presented on the basis that it is a going concern, which contemplates the realization of assets and the satisfaction of liabilities in the normal course of business. At June 30, 2013, the Company had no revenue-generating activities, had negative cash flows from operating activities, and had current liabilities in excess of current assets. These factors create an uncertainty about the Company's ability to continue as a going concern. In this regard, management is proposing to raise any necessary additional funds not provided by operations through loans or through additional sales of common stock. There is no assurance that the Company will be successful in raising this additional capital or in achieving profitable operations. The financial statements do not include any adjustments that might be necessary if the Company is unable to continue as a going concern.

**NOTE 3 RELATED PARTY TRANSACTIONS**

**Related Party Loans** During the six-month period ended June 30, 2013, shareholders or entities controlled by them loaned \$9,380 to the Company. During the six-month periods ended June 30, 2013 and 2012, respectively, the Company accrued interest expense on related party loans totaling \$7,044 and \$5,955.

**NOTE 4 RECENT ACCOUNTING PRONOUNCEMENTS**

The Company has reviewed all recently issued, but not yet adopted, accounting standards in order to determine their effects, if any, on its results of operations, financial position or cash flows. Based on that review, the Company believes that none of these pronouncements will have a significant effect on its financial statements.

**NOTE 5 SUBSEQUENT EVENTS**

The Company has evaluated subsequent events from the balance sheet date through the date the financial statements were issued and determined there are no items to disclose.

**Item 2. Management's Discussion and Analysis of Financial Condition and Results of Operations.**

**Forward-looking Statements**

Statements made in this Quarterly Report which are not purely historical are forward-looking statements with respect to the goals, plan objectives, intentions, expectations, financial condition, results of operations, future performance and our business, including, without limitation, (i) our ability to raise capital, and (ii) statements preceded by, followed by or that include the words may, would, could, should, expects, projects, anticipates, believe, plans, intends, targets or similar expressions.

Accordingly, results actually achieved may differ materially from expected results in these statements. Forward-looking statements speak only as of the date they are made. We do not undertake, and specifically disclaim, any obligation to update any forward-looking statements to reflect events or circumstances occurring after the date of such statements.

**Plan of Operation**

Our plan of operation for the next 12 months is to: (i) consider guidelines of industries in which we may have an interest; (ii) adopt a business plan regarding engaging in the business of any selected industry; and (iii) commence such operations through funding and/or the acquisition of a going concern engaged in any industry selected.

**Results of Operations**

During the quarterly period ended June 30, 2013, we received no revenue and incurred operating expenses of \$4,443, of which \$3,151 was professional fees and \$1,292 was general and administrative expense. We accrued \$3,606 in related party interest expense during the quarter, for a loss from continuing operations before income taxes of \$8,049. After provision for income taxes of \$0, net loss for the quarterly period totaled \$8,049, or \$0.01 per share. During the

quarter ended June 30, 2012, we had a net loss of \$6,210, or \$0.00 per share.

For the six months ended June 30, 2013 we received no revenue and incurred operating expenses of \$14,026, of which \$11,559 was professional fees and \$2,467 was general and administrative expense. We accrued \$7,044 in related party interest expense during the period, for a loss from continuing operations before income taxes of \$21,070. After provision for income taxes of \$0, net loss for the six month period totaled \$21,070, or \$0.02 per share. During the six months ended June 30, 2012, we had a net loss of \$19,547, or \$0.01 per share.

### **Liquidity and Capital Resources**

As of June 30, 2013, we had no cash on hand. During the six months ended June 30, 2013, we received related party loans of \$9,380 to pay our expenses, and at June 30, 2013, we owed a total of \$190,405 to related parties, all of which accrues interest at 8% per annum and is due on demand.

During the next 12 months, our only foreseeable cash requirements will relate to the payment of our Securities and Exchange Commission and Exchange Act reporting filing expenses, as well as associated legal and accounting fees; costs incident to reviewing or investigating any potential business venture; and maintaining our good standing as a corporation in the state of Nevada. We anticipate that these funds will be provided to us in the form of loans from Jenson Services, of which our President, Thomas J. Howells, is the Secretary/Treasurer and a director. There are no written agreements requiring Jenson Services to provide these cash resources; and to the extent funds are provided, such funds will bear interest of 8% and will be due on demand. As of the date of this Quarterly Report, we have not actively begun to seek any business or acquisition candidate.

The design of any disclosure controls and procedures also is based in part upon certain assumptions about the likelihood of future events and there can be no assurance that any design will succeed in achieving its stated goals under all potential future conditions.

Based on that evaluation, our chief executive officer and principal financial officer concluded that, as of June 30, 2013, our disclosure controls and procedures were, subject to the limitations noted above, effective to provide reasonable assurance that information we are required to disclose in reports that we file or submit under the Exchange Act is recorded, processed, summarized and reported within the time periods specified in Securities and Exchange Commission rules, regulations and forms, and that such information is accumulated and communicated to our management, including our chief executive officer and chief financial officer, as appropriate, to allow timely decisions regarding required disclosure.
