These units were deemed acquired effective as of September 1, 2004 at the then current market price of CMS Energy Corporation's Common Stock of \$9.60, and will be settled in cash on the second anniversary of that deemed acquisition date based on the price of the Common Stock at that time.
- (2) These phantom stock units (and related dividend equivalents) were granted on November 1, 2002, pursuant to a deferred salary provision in Mr. Whipple's employment agreement with CMS Energy Corporation, at the then-current market price of \$7.83, and have been settled in cash on the second anniversary of the deemed acquisition date at a current market price of \$9.28 per unit.
