The completion of an acquisition on May 23, 2003 previously reported in a Form 8-K received by the SEC on June 5, 2003 placed unusual challenges on the small business registrant to effect business integration as well as post-transaction audit and accounting consolidation of the newly acquired subsidiary. The registrant anticipates completing the filing requirement within five days of the initial filing due date.
