Reconciliation of all such securities and investments to the books and records of the Company and Mellon Bank;

Confirmation of all securities hypothecated, pledged, placed in escrow, or out for transfer with brokers, pledges, transfer agents or securities lending administrators;

Confirmation of all repurchase agreements, if any, with brokers/banks and agreement of underlying collateral with Mellon Bank's records or to documentation of corresponding subsequent cash receipts;

Agreement of pending purchase activity as of July 31, 2007 to documentation of subsequent cash payments.

5 security purchases and 5 security sales or maturities for the period from June 30, 2007 through July 31, 2007, to the books and records of the Funds noting that they had been accurately recorded and subsequently settled;

Review of Mellon Global Securities Services Report on Controls Placed in Operation and Tests of Operating Effectiveness ("SAS 70 Report") for the period from January 1, 2006 through December 31, 2006 and noted no negative findings were reported in the areas of Asset Custody and Control.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the Company's compliance with specified requirements.
