On December 4, 2007, Coherent, Inc. (the Company ) received an additional NASDAQ Staff Determination letter indicating that the Company is not currently in compliance with NASDAQ 's listing requirements as set forth in Marketplace Rules 4310(c)(14) due to its failure to file its annual report on Form 10-K for the fiscal year ended September 29, 2007. The notice stated that the failure could serve as an additional basis for delisting of the Company 's securities.
