The awards include the right to have stock withheld for tax purposes.

(2) Employee stock option granted pursuant to the Abbott Laboratories 1996 Incentive Stock Program in a transaction exempt from Section 16 under Rule 16b-3. The option becomes exercisable in annual increments of 31,134 on 02/15/2009, 31,133 on 02/15/2010, and 31,133 on 02/15/2011.
