Item 2.02 Results of Operations and Financial Condition

On January 20, 2009, Omnicell, Inc. (Omnicell) issued a press release relating to its updated 2008 year end guidance and its initial guidance for its expected 2009 financial results. On January 20, 2009, Omnicell also announced a company reorganization whereby it appointed current executive, J. Christopher Drew as Senior Vice President, Field Operations. In his new role, Mr. Drew will be responsible for all of Omnicell s customer facing activities. Three general managers each responsible for sales, field installation operations, and field customer service in specific geographical areas of the United States and Canada will report to Mr. Drew. Omnicell also announced the addition of two vice presidents, Marga Ortigas-Wedekind as Vice President, Marketing and Nhat Ngo as Vice President, Strategy and Business Development.
