**Item 2.02 Results of Operation and Financial Condition.**

On January 5, 2017, Helen of Troy Limited (the Company) issued a press release announcing the results for the third fiscal quarter and nine months ended November 30, 2016. Additionally, on January 5, 2017, the Company held a conference call discussing its results for the same period mentioned above. With this Form 8-K, we are furnishing copies of the press release (attached hereto as Exhibit 99.1) and the text of the conference call (attached hereto as Exhibit 99.2).
