- (1) Pursuant to the terms of a governance agreement with the Issuer, on August 21, 2018, the reporting person irrevocably exercised, subject to the expiration or termination of the waiting period under the Hart-Scott-Rodino Antitrust Improvements Act of 1976, as amended (the "HSR Act"), its preemptive right to purchase shares of common stock. Early termination of the waiting period under the HSR Act was granted on September 11, 2018, and the reporting person expects to purchase the shares subject to the preemptive right within 5 business days of such date.
