- (3) This amendment is being filed to correct the Transaction Code in Column 3 of Table I to properly reflect that the Reporting Person's transaction was an acquisition pursuant to Rule 16b-3(d), which is transaction code "A". The Reporting Person's orginal filing inadvertantly reflected transaction code "D" which indicates a disposition to the Issuer of Issuer equity securities pursuant to Rule 16b-3(e).
