(1) Transaction pursuant to reporting person's Rule 10b5-1 instruction.

(2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$48.00 to \$48.01, inclusive. For all transactions reported in this Form 4 utilizing a weighted average share price, the reporting person undertakes to provide to the issuer, any security holder of the issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range.

(3) Represents the approximate number of shares of PG&E Corporation common stock held for the reporting person in the PG&E Corporation Stock Fund of the PG&E Corporation Retirement Savings Plan (RSP). That fund holds units consisting of PG&E Corporation common stock and a small number of short-term investments component. The number of shares is computed by dividing the value of the units by the daily closing price. Dividends are automatically invested in additional units at the election of the participant. These holdings have been trued up to conform to the RSP balance as of 9/7/2010, and reflect the acquisition of approximately 13.80 shares on 4/15/2010 and approximately 14.56 shares on 7/15/2010 due to dividend reinvestment.

(4) The option vested in four installments; 3,363 shares vested on 1/2/2005, 3363 shares vested on 1/2/2006, 3,362 shares vested on 1/2/2007, and 3,362 shares vested on 1/2/2008.

(5) This option vested in four equal installments of 2,175 shares each on 1/3/2006, 1/3/2007, 1/3/2008, and 1/3/2009.
