Number of shares includes 453,750 performance shares (restricted stock units) previously reported that in the future will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting, which vesting will be scheduled to occur as follows: (a) 42,500 shares are scheduled to vest in installments during each July of 2012 and 2013; (b) 75,000 shares are scheduled to vest in installments during each September of 2012 through 2015; (c) 163,750 shares are scheduled to vest in installments during each December of 2012 through 2014; (d) provided specified performance goals are achieved, 22,500 shares will be scheduled to vest in installments during each December of 2012 through 2013; and (e) provided specified performance goals are achieved, 150,000 shares will be scheduled to vest in installments during each December of 2012 through 2015, which number of shares is the target award level, and the actual number of shares that may vest ranges from 0% to 150% of the target amount, depending on achievement of specified performance goals (all vesting will be subject to continued employment through each vest date).
