- (1) On November 8, 2013, Mr. Bischoff exercised 5,000 options set to expire on March 16, 2014. The 4,045 shares that were sold were used to cover the exercise price and related taxes. The remaining 955 shares were held by Mr. Bischoff resulting in a net increase in his ownership of MMC common stock.
- (2) 3,750 of these options become exercisable on July 1, 2007 and the remaining 1,250 of these options become exercisable on March 17, 2008.
