TORONTO, ONT. - Peace Arch Entertainment Group Inc. (Peace Arch) (AMEX: PAE ; TSE: PAE.A , PAE.B) pleased to announce the appointment of Charles Falzon to its Board of Directors subject to the approval of the Toronto Stock Exchange. Charles has had a distinguished career in the fields of television production and distribution having held roles in award-winning television production, sales and marketing, publishing and brand development. In addition, he has a strong corporate and financial background having held the CEO position at Catalyst Entertainment and the position of President at Gullane Entertainment PLC. In 1990, Charles was the founding Chairman of the Canadian Film and Television Production Association and is currently a Governor of the Banff Film Festival.

The Company further reports that it has sold 100% of its shares of its wholly owned subsidiary, Peace Arch Project Development Corp. (PAPDC) to Renegade Motion Picture Corporation of Toronto, Canada. The transaction was for nominal consideration and has no material effect on the earnings of Peace Arch.

GENERAL INSTRUCTIONS

A.

Rule as to Use of Form 6-K,

This form shall be used by foreign private issuers which are required to furnish reports pursuant to Rule 13a-16 or 15d-16 under the Securities Exchange Act of 1934.

B.

Information and Document required to be Furnished,

Subject to General Instruction D herein, an issuer furnishing a report on this form shall furnish whatever information, not required to be furnished on Form 40-F or previously furnished, such issuer (I) makes or is required to make public pursuant to the law of the jurisdiction of its domicile or in which it is incorporated or organized, or (ii) files or is required to file with a stock exchange on which its securities are traded and which was made public by that exchange, or (iii) distributes or is required to distribute to its security holders.

At least one of the copies deposited with the Commission and one filed with each such exchange shall be manually signed. Unsigned copies shall be conformed.
