Peace Arch Entertainment Acquires North American Rights to *What We Do Is Secret*

ACQUISITION OF BIOPIC EXPANDS COMPANY'S 2008

THEATRICAL RELEASE SCHEDULE

Toronto - May 29, 2008 - Peace Arch® Entertainment Group Inc. (AMEX:PAE - News) (TSX:PAE.TO - News), an integrated global entertainment company, today announced that it has acquired all North American distribution rights to the feature biopic *What We Do Is Secret*. Peace Arch will release the film in New York Aug. 8, Chicago Aug. 15 and Los Angeles Aug. 23.

What We Do Is Secret is the true-life story of Darby Crash, who became an LA punk music icon as the front-man for The Germs before taking his own life in 1980.

The film stars Shane West (*A Walk To Remember*, *The League of Extraordinary Gentlemen*, TV's *E.R.* and *Whatever It Takes*), and Bijou Phillips (*Almost Famous*, *Bully* and *Hostel: Part II*). *What We Do Is Secret* was an official selection at several film festivals this year including Philadelphia at which Shane West earned the Rising Star Award for his portrayal of Darby Crash.

What We Do Is Secret was directed by Rodger Grossman, co-written by Grossman and Michelle Baer Ghaffari, and produced by Grossman, Kevin Mann, Stephen Nemeth, Matthew Perniciaro and Todd Traina.

Upcoming U.S. theatrical releases from Peace Arch include the exciting sports drama *Goal II* starring Kuno Becker and Alessandro Nivola, and the road drama *The Go-Getter* starring Lou Taylor Pucci, Zooey Deschanel and Jena Malone.

A.

Rule as to Use of Form 6-K,

B.
