As originally filed, the report erroneously reflected 303,125 shares gifted. The actual number that should have been reported was 181,875. A sixty percent(60%) interest in the shares of common stock were gifted on November 5, 2005, to an entity managed by a third party trustee for the benefit of members of Mr. Knight's family on November 30, 2005. Subsequently, a three for two split occurred increasing the number of shares. Thereafter, on April 25, 2006, the remaining forty percent (40%) interest in the shares of common stock were gifted to another entity managed by a third party trustee for the benefit of members of Mr. Knight's family.
