Also, on June 6, 2006, the Company issued its previously declared stock dividend of one share of Class A Common Stock on each share of Class A Common Stock and each share of Class B Common Stock issued and outstanding on the record date of May 22, 2006. As a result of the stock dividend, Mr. Slark received 17,276 shares of Class A Common Stock.
