- (1) All share amounts are reported based on the number of shares of LiveDeal, Inc. common stock that were publicly traded on August 21, 2007, when the transaction occurred. Effective on August 15, 2007, LiveDeal, Inc. effected a 1-for-10 reverse stock split with respect to issued and outstanding shares of its common stock. As of the date of the reporting person's August 21, 2007 purchase, that reverse stock split was not reflected in the number of shares of LiveDeal, Inc. common stock outstanding on the Over-The-Counter Bulletin Board.
- (2) 62,500 shares of common stock (including the 7,500 shares that were purchased in the transaction that was completed on August 21, 2007) owned by Coury Children Management Trust (the "Trust"), of which the reporting person is a co-trustee. The reporting person disclaims beneficial ownership of the shares owned by the Trust except to the extent, if any, of his pecuniary interest therein.
- (3) 10,093 shares of common stock owned by DLC & Associates Business Consulting, Inc. ("DLC"), of which the reporting person is president. The reporting person disclaims beneficial ownership of the shares owned by DLC except to the extent, if any, of his pecuniary interest therein.
