- (1) These shares are held in a rabbi trust and are deemed to be phantom stock that are convertible on a 1-for-1 basis.

The shares of phantom stock were issued in connection with the Reporting Person's director compensation for the fourth quarter of 2009, and the number of shares of phantom stock issued with respect to the quarter was calculated based on the stock price of the issuer's Class A common stock of \$1.82 (rounded) on December 31, 2009, the last trading day of the quarter.
- (3) Upon termination of the Reporting Person's service as a director, the shares of phantom stock become payable, at the election of the Reporting Person, in a lump sum payment or in monthly, quarterly or annual installment payments following such termination.
