- On December 23, 2009, the reporting person contracted to sell 7,500 shares (the "Shares") of the Issuer's common stock (the "Transaction") in an open market transaction in a sale to be made pursuant to Commission Rule 144. The transaction was mistakenly executed because the broker failed to transmit SEC Form 144 for filing with the Commission concurrently with the reporting person's
- (1) placing the order to execute the Transaction. On January 6, 2010, the broker broke this trade through the broker's error account and rescinded the Transaction. Because the Transaction was effected by mistake, the Form 4 filed on December 28, 2009 to report the Transaction was not required to be filed. This Form 4 is being filed only to report the rescission of the Transaction and the fact that the Shares were not sold.
