This Amendment No. 2 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated January 1, 2011 and filed with the SEC on January 11, 2011 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated December 22, 2016 and filed with the SEC on December 29, 2016 ("Amendment No. 1"), for Bank of America Corporation and Bank of America, N.A. ("BANA") (collectively, the "Reporting Persons") with respect to the auction rate preferred shares ("ARP Shares") of Managed Duration Investment Grade Municipal Fund (the "Issuer"). This Amendment is being filed by the Reporting persons as a result of the August 1, 2017 full redemption by the Issuer of all of its ARP Shares held by the Reporting Persons. The Issuer's principal executive offices are located at 200 Park Avenue, 7th Floor, New York, NY 10166.
