The undersigned Registrant hereby makes application, pursuant to paragraph (a) of Rule 477 under the Securities Act of 1933, as amended, to withdraw Post-Effective Amendment No. 1 to the Registration Statement on Form S-1 (SEC File No. 333-140117), originally filed with the Securities and Exchange Commission (the "Commission") on April 10, 2007.

Post-Effective Amendment No. 1 was filed solely for the purpose of converting the existing registration statement to Form S-3 to allow USOF to incorporate by reference its periodic and current reports under the Securities Exchange Act of 1934. Pursuant to correspondence from the staff, we were informed that USOF will not become S-3 eligible until twelve calendar months following its initial public offering, or May 1, 2007.
