**Item 1. Security and Issuer**

This Schedule 13D relates to the Common Stock, par value \$0.001 per share (the “Common Stock”) of MusclePharm Corporation, a Nevada corporation (the “Issuer”), whose principal executive offices are located at 4721 Ironton Street, Building A, Denver, Colorado 80239.

**Item 2. Identity and Background.**

- (a) Brad Pyatt is an individual (the “Reporting Person”).
- (b) The business address of Mr. Pyatt is 4721 Ironton Street, Building A, Denver, Colorado 80239.
- (c) Mr. Pyatt is the Chief Executive Officer, President and Co-Chairman of the Board of Directors of the Issuer.
- (d) Mr. Pyatt has not, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (e) Mr. Pyatt has not, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or state securities laws or finding any violation with respect to such laws.
- (f) Mr. Pyatt is a citizen of the United States.

**Item 3. Source and Amount of Funds or Other Consideration.**

Brad Pyatt

Since, April 15, 2011, the date of the filing of the original Schedule 13D which this filing amends, through grants directly from the Issuer as compensation for services provided and dispositions on his own, the Reporting Person's ownership has increases as such so that the Reporting Person currently owns 515,418 shares of the Issuer's common stock.

**Item 4. Purpose of Transaction.**

The shares acquired by the Reporting Person were issued for the purpose of acquiring an interest in the, notwithstanding the Reporting Person's role as an executive and director of the Issuer.

Except as set forth herein, the Reporting Person has no plans or proposals which would relate or result in:

- (a) The acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer;
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries;
- (c) A sale or transfer of a material amount of assets of the issuer or any of its subsidiaries;
- (d) Any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) Any material change in the present capitalization or dividend policy of the issuer;
- (f) Any other material change in the issuer's business or corporate structure including but not limited to, if the issuer is a registered closed-end investment company, any plans or proposals to make any changes in its investment policy for which a vote is required by section 13 of the Investment Company Act of 1940;

(g) Changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person;

(h) Causing a class of securities of the issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;

(i) A class of equity securities of the issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act; or

(j) Any action similar to any of those enumerated above.



**Item 5. Interest in Securities of the Issuer.**

Mr. Pyatt may be deemed to be the beneficial owner of 515,418 shares of the Issuer's common stock, which constitutes approximately 5.79% of the 8,890,990 shares of the Issuer's common stock outstanding as of October 4, 2013.

Other than the acquisition of the shares reported in this Item 5, the Reporting Persons have effected no transactions in the shares of the Issuer during the past 60 days.

No persons other than the Reporting Persons has the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the shares reported above in this Item 5.

Other than as set forth above, Mr. Pyatt is not the beneficial owners of any other shares of the Issuer's common stock.
