## **POLL RESULTS OF THE 2013 ANNUAL GENERAL MEETING**

**AND**

## **AMENDMENTS OF ARTICLES OF ASSOCIATION**

The Board announces the poll results of the AGM held in Shanghai, the PRC on Thursday, 26 June 2014.

Reference is made to the notice dated 9 May 2014 (the "**Notice**") and the further notice dated 30 May 2014 (the "**Further Notice**") regarding the 2013 annual general meeting (the "**AGM**") of China Eastern Airlines Corporation Limited (the "**Company**") held on Thursday, 26 June 2014. Terms defined in the Notice shall have the same meanings when used herein unless otherwise specified.

## **POLL RESULTS OF THE AGM**

The AGM was held at Four Season Hall, 2/F, Shanghai International Airport Hotel ( ), 2550 Hongqiao Road Shanghai, the PRC on Thursday, 26 June 2014. Shareholders representing 10,361,523,794 shares of the Company (the “**Share**”) were present, in person or by proxy, at the AGM. The AGM was validly convened in compliance with the relevant requirements under the Company Law of the PRC and the Articles of Association.

As at the date of the AGM, the total number of Shares entitling the holders to attend and vote on each of the proposed resolutions at the AGM was 12,674,268,860.

There was no Share entitling the Shareholders to attend and abstain from voting in favour as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No Shareholder was required under the Listing Rules to abstain from voting at the AGM.

Each resolution proposed for approval at the AGM was taken by poll.

Ernst&Young, the auditors of the Company were appointed as the scrutineer for the purpose of vote-taking at the AGM. The poll results in respect of the resolutions proposed for approval at the AGM were set out as follows:

- 7.(2) Issuer: The Company and/or its wholly or non-wholly owned subsidiaries. The exact issuer shall be determined by the Board based on the needs in the particular issuance.

- (3) Issue size: Debt instruments shall be issued under this mandate within the cap amount of bond issuance stipulated under applicable laws, subject to the outstanding amount of each type of debt instrument. The actual size of issue shall be determined by the Board based on funding requirements and market conditions.

- (4) Maturity and class of issue: Not more than 15 years in the form of a uniform maturity date or a bond portfolio with several maturity dates. The actual composition of maturity and the size of each class of the bonds shall be determined by the Board based on relevant requirements and market conditions.

- (5) Use of proceeds: It is expected that the proceeds from such issuance shall be used for purposes in compliance with laws and regulations, including satisfying the production and operation needs of the Company, adjusting debt structure, supplementing working funds and/or project investment. Details of the use of proceeds shall be determined by the Board based on funding requirements.

- (6) Valid term of mandate: One year from the approval of this resolution by the share holders of the Company (the “**Shareholders**”) in a general meeting of the Company.

If the Board and/or its delegate(s) has decided to proceed with issuance(s) within the valid term of the mandate, and the Company has obtained issuance approval, permission or registration from regulatory bodies within the valid term of the mandate, the Company may complete the relevant issuance within the valid term confirmed under any of such approval, permission or registration.

Authorisation to be granted to the Board

- 7.(7) An authorisation be and is hereby granted generally and unconditionally to the Board, based on the specific needs of the Company and other market conditions:

To determine the issuer, type, specific class, specific terms, conditions and other matters, including but not limited to the actual issue size, the actual total amount, currency, issue price, interest rates or the formula for determining the interest rates,

- (i) place of issuance, timing of the issue, maturity, whether or not to issue in tranches and the number of tranches, whether to set buyback and redemption clauses, rating arrangements, guarantees, due dates for principal and interest payments, use of proceeds, underwriting arrangements and all matters relating to the issue.

To take all such acts and steps as considered to be necessary and incidental to this issuance, including but not limited to the engagement of intermediary(ies) to represent

“The Company’s profit distribution should pay close attention to ensuring a reasonable return of investment to investors, and such profit distribution policy should maintain continuity and stability. **The Company shall reasonably distribute dividends** according to laws and regulations and requirements of securities regulatory authorities, as well as the Company’s own operating performance and financial condition, **and shall adopt cash distribution as the prioritised means of distribution to distribute profit.**”

Article 157(F) of the existing Articles of Association is as follows:

“Intervals for profit distribution by the Company: Provided that the conditions of profit distribution are met and the Company’s normal operation and sustainable development are ensured, the Company shall generally distribute profit on an annual basis. The board of directors of the Company may also propose interim profit distribution based on the profitability and capital position of the Company.”
