**Item 1. Security and Issuer.**

This statement relates to common stock, par value \$.001 per share (the “Common Stock”) of SMG Indium Resources Ltd. (the “Issuer”). The Issuer’s principal executive office is located at 710 N. Post Road, Suite 400, Houston, Texas 77024.

**Item 2. Identity and Background.**

(a) This statement is filed by the Flemming Family Trust (the “Trust”) and Matthew Flemming (the “Trustee”).

(b) The address for the Trust and the Trustee is c/o SMG Indium Resources Ltd., 710 N. Post Oak Road, Suite 400, Houston, Texas 77024.

(c) The Trustee is the Chairman and Chief Executive Officer of the Issuer.

(f) The Trust is organized in the State of Texas and the Trustee is a United States citizen.

**Item 3. Source or Amount of Funds or Other Consideration.**

The Trust acquired 600,000 shares of the Issuer’s Common Stock (the “Shares”) pursuant to the Agreement and Plan of Share Exchange entered into by and between the Issuer, MG Cleaners LLC and all of the members of MG Cleaners LLC on September 19, 2017. In connection with the transaction, the Trust exchanged all of the membership interests of MG Cleaners LLC owned by the Trust for the Shares.

**Item 4. Purpose of Transaction.**

See Item 3 above.

**Item 5. Interest in Securities of the Issuer.**

The Trust and the Trustee, by virtue of his power to dispose or direct the disposition of and to vote or direct the vote of the shares of Common Stock on behalf of the Trust, are each deemed to be the beneficial owner of 600,000 (a) shares of Common Stock of the Issuer, which represents 8.4% of the Issuer's issued and outstanding shares of Common Stock, based on 7,125,190 shares of the Issuer's Common Stock issued and outstanding as of the date hereof.

(b) Number of Shares as to which the Trust and the Trustee have:

(i) Sole power to vote or to direct the vote

The Trust and the Trustee each have sole voting power with respect to zero shares of the Issuer's Common Stock;

(ii) Shared power to vote or direct the vote

The Trust and the Trustee each have shared voting power with respect to 600,000 shares of the Issuer's Common Stock;

(iii) Sole power to dispose or to direct the disposition of

The Trust and the Trustee each have sole power to dispose or direct the disposition of zero shares of the Issuer's Common Stock; and

(iv) Shared power to dispose or to direct the disposition of

The Trust and the Trustee each have shared power to dispose or direct the disposition of 600,000 shares of the Issuer's Common Stock.



**Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer.**

Neither the Trust nor the Trustee are party to any contracts, arrangements, understandings or relationships with respect to the securities of the Issuer.
