Item 2.02. Results of Operations and Financial Condition.

On April 26, 2013, Ventas, Inc. (the “Company”) issued a press release announcing its results of operations for the quarter ended March 31, 2013. A copy of the press release is furnished herewith as Exhibit 99.1 and incorporated in this Item 2.02 by reference.

The press release states that the Company’s normalized funds from operations (“FFO”) for the quarter ended March 31, 2013 were \$301.6 million, or \$1.03 per diluted common share, as compared to \$263.9 million, or \$0.91 per diluted common share, for the quarter ended March 31, 2012. FFO, as defined by the National Association of Real Estate Investment Trusts (“NAREIT”), for the quarter ended March 31, 2013 was \$295.3 million, or \$1.00 per diluted common share, as compared to \$214.8 million, or \$0.74 per diluted common share, for the quarter ended March 31, 2012. The Company’s net income attributable to common stockholders for the first quarter of 2013 was \$112.2 million, or \$0.38 per diluted common share (including discontinued operations of \$(5.6) million), as compared to \$90.6 million, or \$0.31 per diluted common share (including discontinued operations of \$43.4 million), for the comparable period in 2012.

The press release also states that the Company continues to expect its normalized FFO for the year ending December 31, 2013 to be between \$3.99 and \$4.07 per diluted common share. The Company expects its net income attributable to common stockholders for 2013 to be between \$1.22 and \$1.45 per diluted common share.
