(3) EXPLANATION OF ANTICIPATED CHANGE

The Registrant expects to report revenues of approximately \$48.0 million to \$49.0 million for the calendar year ended December 31, 2006, compared to \$47.3 million in revenue reported for calendar year 2005. For the calendar year ended December 31, 2006, the Registrant expects to report a net income between approximately \$250,000 and \$310,000, compared to a net loss of \$29.5 million for 2005.
