extent of their respective indirect pecuniary interests in the Issuer.

- Mr. Bunce is a 9.9% shareholder of HFCI Bermuda, but is not a member of the Investment Committee. Other than the 7,001 Common Shares and the 3,300 options to purchase Common Shares granted to Mr. Bunce in consideration for his service as a director of the Issuer, the H&F entities described in Footnote 1 own 9,348,044 Common Shares.

- Mr. Bunce may be deemed to have an indirect pecuniary interest (within the meaning of Rule 16a-1 under the Securities Exchange Act of 1934) in an indeterminate portion of the Common Shares beneficially owned by the Partnerships. Mr. Bunce disclaims beneficial ownership of all Common Shares beneficially owned by these entities, including an aggregate of 7,001 Common Shares and 3,300 options to purchase Common Shares granted to Mr. Bunce in consideration for his service as a director of the Issuer, except to the extent of his indirect pecuniary interest in the Issuer held through such entities.

- Includes 7,001 Common Shares granted to Mr. Bunce in consideration for his service as a director of the Issuer, which are held for the benefit of the Partnerships. Mr. Bunce disclaims beneficial ownership of these 7,001 Common Shares except to the extent of his indirect pecuniary interest in the Issuer held through the Partnerships.
