- (1) The underlying Restricted Stock Units ("RSUs") were granted in a transaction exempt under Rule 16b. Upon vesting, RSUs are converted into an equivalent number of shares of Common Stock that are distributed to the grantee.

As previously reported, on January 28, 2014, the reporting person was granted 877 RSUs, 293 of which vested on January 28, 2015 and converted into shares of common stock on such date. Dividend equivalent rights accrue with respect to the unvested RSUs when and as dividends are paid on Hexcel common stock. The 1.27 dividend equivalent rights reflect dividend equivalent rights at \$45.87 per RSU credited to the reporting person's account on February 17, 2015.
