- (1) The total beneficial ownership includes 7.0271 shares at \$26.2924 per share acquired through dividends paid in shares on 07/15/13 under the HP 2011 Employee Stock Purchase Plan ("ESPP"). The total beneficial ownership also includes the acquisition of 2.9470 shares at \$25.2343 per share received on 07/05/13 through dividends paid in shares.
- (2) The price in Column 4 is a weighted average price. The prices actually paid ranged from \$22.6100 to \$22.6110. Upon request, the reporting person will provide to the Issuer, any security holder of the Issuer, or the SEC staff information regarding the number of shares

purchased at each price within the range.

- (3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(4) As previously reported, on 12/10/10 the reporting person was granted 6,000 restricted stock units ("RSUs"), 2,000 of which vested on each of 12/10/11 and 12/10/12, and 2,000 of which will vest on 12/10/13. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 11.5330 dividend equivalent rights being reported reflect 11.5330 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13.

(5) As previously reported, on 12/07/11 the reporting person was granted 15,000 restricted stock units ("RSUs"), 5,000 of which vested on 12/07/12, and 5,000 of which will vest on each of 12/07/13 and 12/07/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 57.6648 dividend equivalent rights being reported reflect 57.6648 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13.

(6) As previously reported, on 05/16/12 the reporting person was granted 12,000 restricted stock units ("RSUs"), 4,000 of which vested on 05/16/13, and 4,000 of which will vest on each of 05/16/14 and 05/16/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 46.1319 dividend equivalent rights being reported reflect 46.1319 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13.

(7) As previously reported, on 12/06/12 the reporting person was granted 65,076 restricted stock units ("RSUs"), 21,692 of which will vest on each of 12/06/13, 12/06/14, and 12/06/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 375.2595 dividend equivalent rights being reported reflect 375.2595 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13.
