Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 226,172 dividend equivalent rights being reported reflect 226,172 dividend equivalent rights at \$21.40 per RSU credited to the reporting person's account on 10/02/13.
- (2) As previously reported, on 12/06/12 the reporting person was granted 40,000 restricted stock units ("RSUs"), 13,333 of which vested on 12/06/13, 13,333 of which will vest on 12/06/14, and 13,334 of which will vest on 12/06/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
