- (1) Disposed of pursuant to the Agreement and Plan of Merger, dated as of April 30, 2006, by and among The Boeing Company ("Boeing"), Boeing-Avenger, Inc. and Aviall, Inc. (the "Merger Agreement") in exchange for a cash payment of \$211,584, or \$48.00 per share.  

This option, granted pursuant to the Aviall, Inc. Amended and Restated 1998 Directors Stock Plan which provided for vesting on July 1, 2004, was cancelled in the merger in exchange for a cash payment of approximately \$110,160, which is equal to the excess of \$48.00 per share over the per share exercise price subject to such option.
- (2) This option, granted pursuant to the Aviall, Inc. Amended and Restated 1998 Directors Stock Plan which provided for vesting on February 2, 2005, was cancelled in the merger in exchange for a cash payment of approximately \$163,125, which is equal to the excess of \$48.00 per share over the per share exercise price subject to such option.
- (3) This option, granted pursuant to the Aviall, Inc. Amended and Restated 1998 Directors Stock Plan which provided for vesting on February 1, 2006, was cancelled in the merger in exchange for a cash payment of approximately \$98,700, which is equal to the excess of \$48.00 per share over the per share exercise price subject to such option.
- (4) This option, granted pursuant to the Aviall, Inc. Amended and Restated 1998 Directors Stock Plan which provided for vesting on January 26, 2007, was cancelled in the merger in exchange for a cash payment of approximately \$78,750, which is equal to the excess of \$48.00 per share over the per share exercise price subject to such option.
