As part of the HCC Board of Directors compensation package, each non-employee Director receives a grant of HCC common stock in the amount of the number of shares determined by dividing \$80,000 by the closing price on the date of the Annual Meeting of Shareholders.

- (1) If a director is appointed on a date other than the Annual Meeting date, he receives a pro-rata portion of the \$80,000 grant. Mr. Rosolt was appointed on August 20, 2008 and received as a pro-rated amount, \$58,301 in HCC shares. Therefore, at the closing price of \$24.02, he received 2,427 shares.
