Mr. Ferrante, BCM and BCI disclaim beneficial ownership of such securities except to the extent of their pecuniary interest therein. On November 18, 2010 BCP sold 1,800 shares of Common Stock. Following such sale, BCP held 107,838 shares of Common Stock.
