CIBC Trust Company (Bahamas) Limited, solely in its capacity as trustee of the Reporting Person, had previously executed a joinder to, and thereby is already subject to the provisions of, the Amended and Restated Foreign Global Hyatt Agreement. Accordingly, immediately following the receipt of shares, the shares will remain shares of Class B Common Stock.
