(1) The common shares were acquired pursuant to an allocation under the Corporation's Executive Investment Share Purchase Plan (which replaced the Executive Incentive Share Compensation Plan) in 2004 and 2005 (the "Plan"). The U.S. dollar price represents the conversion of (Cdn)\$17.23 to U.S. dollars on December 30, 2005, which reflects the date used for purposes of the trustee's allocation.

(2) Represents unvested Shares held in trust that were acquired pursuant to the Plan in 2003, 2004 and 2005. The reporting individual also holds 31,368 Shares held directly; 5,482 vested Shares held pursuant to the Restated Cott USA 401(k) Savings and Retirement Plan (as at 11/30/05); and 135.015 Shares held in trust pursuant to the Plan that vested on or before 01/02/05. Additionally, 3,000 shares are held by his son.
