Unilever NV and Unilever PLC - Transactions in Own Shares

Unilever NV announces that on 1 December 2005, it purchased 110,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 57.05 and euro 57.75 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 3,780 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 23,925,417 Unilever NV ordinary shares in treasury, and has 547,650,483 Unilever NV ordinary shares in issue (excluding treasury shares).

Unilever PLC announces that on 1 December 2005, it purchased 700,000 Unilever PLC ordinary shares at prices between 565.00 pence and 567.00 pence per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever PLC holds 22,496,587 Unilever PLC ordinary shares in treasury, and has 2,888,961,993 Unilever PLC ordinary shares in issue (excluding treasury shares).
