#### Item 1.01. Entry into a Material Definitive Agreement.

Description of the Notes and the Mortgage Loans

Accredited Home Lenders, Inc. and Accredited Mortgage Loan REIT Trust (the <u>Registrants</u>) have registered issuances of an aggregate of up to \$4,000,000,000 in principal amount of asset-backed securities, on a delayed or continuous basis pursuant to Rule 415 under the Securities Act of 1933, as amended (the <u>Act</u>), by a Registration Statement on Form S-3 (Registration File Nos. 333-124435 and 333-124435-01) (as amended, the <u>Registration Statement</u>). Pursuant to the Registration Statement, Accredited Mortgage Loan Trust 2005-4, a Delaware statutory trust, issued \$1,186,150,000 in aggregate principal amount of its Accredited Mortgage Loan Asset-Backed Notes, Series 2005-4 (the <u>Notes</u>) on November 23, 2005 (the <u>Closing Date</u>).

The Amended and Restated Trust Agreement filed in connection with the Notes is hereby amended pursuant to Amendment Number 1 to the Amended and Restated Trust Agreement, dated as of October 31, 2006 attached hereto as Exhibit 4.2, among Accredited Home Lenders, Inc., as sponsor, Accredited Mortgage Loan REIT Trust, as depositor and U.S. Bank Trust National Association, as owner trustee.
