Announcement regarding Issuance of New Shares and Secondary Offering of Shares,

and Withdrawal of Shelf Registration Statement in Japan for Future Equity Issuances

Mizuho Financial Group, Inc. (MHFG) hereby announces that its board of directors resolved today to issue new shares and conduct a secondary offering of its shares, and to withdraw the shelf registration statement in Japan for future equity issuances, as set forth below:

A Japanese Initial Purchaser (the Japanese Initial Purchaser) shall underwrite and purchase all of the new shares with respect to the Japanese Public Offering; and several Japanese underwriters (the Japanese Underwriters) shall handle the Japanese Public Offering of the shares. Moreover, in the case where the shares remain unsubscribed, the Japanese Underwriters shall jointly and severally subscribe for such shares from the Japanese Initial Purchaser.

(ii) International offering:

The offering to be made in overseas shall be conducted through an offering in overseas market (provided that the offering shall be made, in the United States, to qualified institutional buyers only and, in Canada, to accredited investors only) (the International Offering). 1. Japanese Secondary Offering by way of Over-Allotment and other matters

The Japanese Secondary Offering by way of Over-Allotment as mentioned in 2. Secondary Offering of Shares (Japanese Secondary Offering by way of Over-Allotment) above, is a secondary offering in Japan to be made in relation to the Japanese Public Offering mentioned in (4) (i) of 1. Issuance of New Shares by way of Offering (Public Offering) for shares of common stock of MHFG, in a number not to exceed 195,600,000 shares, that will be borrowed by one of the Joint Lead Managers of the Japanese Public Offering from certain shareholder(s) of MHFG, taking into account market demand for the offerings mentioned above and other conditions. The number of shares to be offered in the Japanese Secondary Offering by way of Over-Allotment is scheduled to be 195,600,000 shares; however, this is the maximum number of shares to be sold, and such number may decrease, or the Japanese Secondary Offering by way of Over-Allotment may be cancelled entirely, depending on market demand and other conditions.

In connection with the Japanese Secondary Offering by way of Over-Allotment, the board of directors of MHFG has resolved, at the meeting held on Wednesday, July 1, 2009, that MHFG will issue 195,600,000 shares of its common stock to the Joint Lead Manager referred to in the previous paragraph (the Allottee) by way of third-party allotment (the Capital Increase by way of Third-Party Allotment), with the payment date set to be Wednesday, August 5, 2009, as set forth in 3. Issuance of New Shares by way of Third-Party Allotment, in order for the Allottee to obtain the number of shares necessary to return the shares of common stock of MHFG that were borrowed by the Allottee from certain shareholder(s) of MHFG, as mentioned above (the Borrowed Shares).

The shares of common stock of MHFG purchased through such stabilizing transactions may be used, in part or in whole, to return the Borrowed Shares.

In addition to the above, the shares of such common stock purchased through such stabilizing transactions may be transferred, in part or in whole, to the International Initial Purchaser for the purpose of settlement of shares in respect of the International Offering.

With respect to the number of shares obtained by deducting (a) the number of shares purchased through stabilization transactions and Syndicate Cover Transactions that are to be used to return the Borrowed Shares from (b) the number of shares to be offered in the Japanese Secondary Offering by way of Over-Allotment, the Allottee will accept the allotment under the Capital Increase by way of Third-Party Allotment and will purchase an equivalent number of shares of common stock of MHFG. As a result, a part or all of the shares to be issued under the Capital Increase by way of Third-Party Allotment may not be subscribed for, which may result in a decrease in the definitive number of shares to be issued under the Capital Increase by way of Third-Party Allotment, or in the entire cancellation of the issuance.

In light of the current uncertainty over the economy, MHFG believes that this issuance will allow MHFG to hold a solid and sufficient capital buffer in preparation for a further adverse business environment, and to enhance flexibility to re-capture business opportunities with our solid customer base to lead to our sustainable growth.

4. Profit distribution to shareholders, etc.

(1) Basic policy concerning profit distribution

MHFG is pursuing strengthening of stable capital base and steady returns to shareholders as its disciplined capital management .

(2) Concept of determination of dividends

MHFG will determine the cash dividend payment per share of common stock for each fiscal year, from the standpoint of providing stable periodic dividend payments to its shareholders, taking into account consolidated financial results, retained earnings and other factors.

(3) Use of retained earnings

MHFG will utilize the retained earnings as a source to strengthen its financial position and for future development of its business.

(5) Others

MHFG is pursuing strengthening of stable capital base and steady returns to shareholders as its disciplined capital management. In July 2008, MHFG repurchased its own shares (common stock) of JPY149.9 billion and cancelled almost all of them in September 2008 for the purpose of offsetting the potential dilutive effect on its common stock from the conversion of the Eleventh Series Class XI Preferred Stock. However, in light of factors including the current financial market turmoil and global economic downturn, MHFG has been putting more priority on strengthening of stable capital base since the second half of fiscal year 2008 in order to prepare for a further adverse business environment. MHFG will continue to focus on enhancement of capital as the key issue of future management since it has become increasingly important for financial institutions to maintain a sufficient capital base amid a prolonged stagnation of both domestic and overseas economies.

More specifically, MHFG's medium-term target is to increase our Tier 1 capital ratio to 8% level. Further, MHFG aims to maintain its prime capital, which is an item constituting the capital having particularly strong ability to absorb losses among types of Tier 1 capital, at a level of more than half of our Tier 1 capital. Prime capital is calculated as Tier 1 capital less preferred securities less preferred stock (excluding mandatory convertible preferred stock to which common stock is delivered in consideration of mandatory conversion of such preferred stock). MHFG will continue to pursue disciplined capital management through management that is optimally balanced between strengthening of stable capital base and steady returns to shareholders in accordance with changes in business environment.
