<b>Interest Payment Dates:</b>	Interest will be paid semiannually on May 6 and November 6, beginning on November 6, 2010, to holders of record as of the preceding April 22 and October 22, respectively.
<b>Day Count:</b>	30/360
<b>Use of Proceeds:</b>	The net cash proceeds from the sale will be used for general corporate purposes. Pending such use, we may temporarily invest net proceeds in interest-bearing, investment-grade securities.
<b>Exchange Listing:</b>	The Notes will not be listed on any national securities exchange.
<b>Denomination:</b>	We will issue the Notes in denominations of \$1,000 and in integral multiples thereof.
