**(e) Compensatory Arrangements of Certain Officers**

On December 21, 2011, the Board of Directors of Northrop Grumman Corporation (the Company ) approved changes to certain executive benefits as follows:

the accrued benefit of participants in the CPC Supplemental Executive Retirement Program and the Officers Supplemental Executive Retirement Program (collectively the Executive Plans ) will be frozen effective December 31, 2014; and

all executive officers who previously participated in the Executive Plans and not the Northrop Grumman Officers Retirement Account Contribution Plan (the ORAC ), will transfer to and commence participating in the ORAC effective January 1, 2015.
