**Subject: Court Approves Merger Agreement and Exclusivity Extension Request**

**Summary**

Today, Bankruptcy Court Judge Sean Lane approved the merger agreement between American and US Airways. This approval allows us to continue progressing forward with our planned merger, and we are gratified to know that the Court considers the merger an excellent result for stakeholders.

**Key Points**

Judge Lane approved the merger agreement, but indicated that the CEO compensation arrangement might be more appropriately considered as part of the Plan of Reorganization. We await his written ruling that will address this in more detail.

As a result of the evidence presented in today's hearing, the U.S. Trustee withdrew its other objections, so all of the other employee compensation arrangements have been approved as part of the merger agreement. However, they are still subject to approval of the Plan of Reorganization and closing of the merger.

The Court also approved American's final exclusivity extension request, which provides AMR until May 29 to file our Plan of Reorganization.

We are pleased to have received these approvals as we move forward in building the new American.
