Effective April 10, 2014, Deborah D. Snow, Senior Vice President, Human Resources of Allscripts Healthcare Solutions, Inc. (the Company), is no longer employed by the Company. In connection with her departure, the Company and Ms. Snow entered into a Separation Agreement (the Agreement).
