(d) On August 5, 2015, the board of directors of General Dynamics Corporation elected Mark Malcolm as a member of the board of directors, effective immediately. As a non-employee director, Mr. Malcolm will receive the same compensation paid to other non-employee directors of the company as disclosed under the caption "Director Compensation" in the company's proxy statement filed with the Securities and Exchange Commission on March 20, 2015.
