**Item 8.01 Other Events.**

On July 27, 2016, Fifth Third Bancorp entered into an agreement with Vantiv, Inc. under which a portion of its Tax Receivable Agreements (TRA) with Vantiv were terminated and settled in full for consideration of a cash payment in the amount of \$116.3 million from Vantiv. Under the agreement, Fifth Third Bancorp terminated and settled certain TRA cash flows it expected to receive in the years 2019 to 2035, totaling an estimated \$330.7 million. Fifth Third expects to realize a pre-tax gain of \$116.3 million from this settlement in the third quarter of 2016.

Additionally, the agreement provides that Vantiv may be obligated to pay up to a total of approximately \$170.7 million to Fifth Third to terminate and settle certain remaining TRA cash flows, totaling an estimated \$394.1 million, upon the exercise of certain call options by Vantiv or certain put options by Fifth Third. If the associated call options or put options are exercised, 10% of the obligations would be settled with respect to each quarter in 2017 and 15% of the obligations would be settled with respect to each quarter in 2018. Fifth Third expects to recognize a pre-tax gain and corresponding receivable of approximately \$162.6 million in the third quarter of 2016 associated with these options.

This agreement does not impact the TRA payments expected to be recognized in the fourth quarter of 2016 and the fourth quarter of 2017 which are expected to be received in the first quarter of 2017 and the first quarter of 2018, respectively.
