Borin, the Company's current Senior Vice President, Chief Accounting Officer and Treasurer, is expected to be the Company's Chief Financial Officer and no longer serve as the Company's Chief Accounting Officer after the completion of the Separation. John L. Stauch, the Company's current Executive Vice President and Chief Financial Officer, is expected to be the Company's Chief Executive Officer as previously announced and no longer serve as the Company's Chief Financial Officer after completion of the Separation.
