No new annual incentive award opportunities will be provided under the SEAIP after December 13, 2018, and it is expected that future annual incentive awards to senior executives will be granted under the PolyOne Corporation 2017 Equity and Incentive Compensation Plan (or any successor plan that may be adopted in the future).
