- (1) On March 12, 2004, June 1, 2004 and June 1, 2005, NRG Energy, Inc. (the "Company") issued 4,412; 2091; and 1,226 Deferred Stock Units ("DSU?s"), respectively, to Mr. Tate under the Company?s Long-Term Incentive Plan. Each DSU is equivalent in value to one share of the Company?s Common Stock, par value \$0.01. On January 1, 2006, 1,932 of such DSU?s (25% (1,103) from the March 12, 2004 grant, 25% (522) from the June 1, 2004 grant and 25% (307) from the June 1, 2005 grant) were exchanged for such Common Stock on a one-to-one basis. Mr. Tate sold the shares in order to cover the tax liability associated with the exchange of DSU?s to Common Stock.
